
Those who are planning to write a proposal to the upcoming 2022 Postdoctoral Fellowships might have an idea about the application statistics of the previous call via this document.








3. Submitted eligible EF Proposals by Panels (7439 in total)




4. Submitted eligible GF Proposals by Panels (808 in total)






5. Submitted-Funded-Reserve List Eligible Proposals (for all 8247 proposals)




6. Main list (Number of proposals retained for funding) for EF Panel (1025 in total)






7. Main list (number of proposals retained funding) for GF Panel (131 in total)




8. Submitted-Funded Participants (for all 9672 participants)






9. Cut-off scores (Main list) by EF panels




10. Cut-off scores (Main list) by GF panels






11. Cut-off scores (Reserve list) by EF panels




12. Cut-off scores (Reserve list) by GF panels






13. Success rate (according to number of evaluated EF panel proposals)




14. Success rate (according to number of GF panel proposals)






15. Type of Organisations for Applicants (for all 9672 participants)




16. SME Participation among all (9672) participants (including GF partners)






17. SME participation among all funded (1156) participants (including GF partners)




18. Gender of coordinators (person-in charge) among (8247) submitted eligible proposals






19. Gender of coordinators (person-in charge) in Main list




20. Gender of researchers among submitted (8247) eligible proposals






21. Number of experts (4106 in total)




22. Type of experts' institutions






23. Submitted eligible proposals from EU Member States (for all 6796 proposals)




24. Submitted eligible proposals from Associated Countries (for all 2000 proposals)
