


Those who are planning to write a proposal to the upcoming 2023 COFUND might have an idea about the application statistics of the previous call via this document.








3. Submitted-Funded-Reserve list for eligible proposals (for 102 participants)




4. Submitted-Funded participants (for all 1442 participants)






5. Gender of coordinators (applicants' person-in charge) among submitted eligible proposals




6. Gender of coordinators (applicants' person-in charge) in main list






7. SME coordinators in main list




8. SME coordinators among submitted eligible proposals






9. Cut-off score (main list) by panels




10. Cut-off score (reserve list) by panels






11. Success rate by panels




12. Number of experts (80) in total






13. Type of organisations for coordinators (for all 1442 participants)
