#### 1. Introduction










3. Submitted eligible EF Proposals by Panels (7084 in total)
















7. Main list (number of proposals retained funding) for GF Panel (133 in total)













#### 13. Success rate (according to number of evaluated EF panel proposals)
















#### 19. Gender of coordinators (person-in charge) in Main list









